

# 1-2-3 ACTION PLAN TO STOP EXPOSURE TO 4G AND 5G SMALL CELLS!

1. **LEARN WHY 4G AND 5G SMALL CELLS ARE SO UNSAFE** – NOT JUST AN UPGRADE - IT IS CLOSE RANGE EXPOSURE TO HIGH LEVELS OF CONTINUOUS, INVOLUNTARY, DANGEROUS MICROWAVE RADIATION. 4G (small cells) are the backbone of the 5G infrastructure and is put in first, then 5G small cells are added. Both types of exposures are very hazardous. 2. **SHARE WHAT YOU LEARN** WITH EVERYONE YOU KNOW, ON SOCIAL MEDIA AND IN PERSON
3. **TAKE ACTION QUICKLY BEFORE SMALL CELLS TAKE OVER YOUR COMMUNITY**
  - A. **FILE AN ADA ACCOMMODATIONS REQUEST** with your local municipality if you have a medical condition and are sensitive to rf radiation – directions at [www.electrosmogprevention.org](http://www.electrosmogprevention.org)
  - B. **BOYCOTT 5G PRODUCTS AND ALL WIRELESS**
  - C. **HOLD 5G INFO MEETINGS IN YOUR COMMUNITY** – spread the word in social media
  - D. **START A STOP 5G \_\_\_\_\_ FB PAGE / GROUP FOR YOUR OWN COMMUNITY**
  - E. **DISTRIBUTE 5G INFO FLIERS WIDELY** <https://ehtrust.org/factsheet-need-know-5g-small-cells-science-policy-public-health/> and see Toolkit below
  - F. **WRITE**
    - a. WRITE AND CALL YOUR LOCAL GOVERNMENT AND ALL ELECTED OFFICIALS – STATE LEGISLATORS, OUR GOVERNOR, YOUR MEMBERS OF CONGRESS, AND THE PRESIDENT (See letters on [http://www.electrosmogprevention.org/stop-5g-action-plan/10-actions-to-help-stop-5g/and Stop 5G California site](http://www.electrosmogprevention.org/stop-5g-action-plan/10-actions-to-help-stop-5g/and-Stop-5G-California-site)).
    - b. WRITE AND CALL TELECOM COMPANIES to tell them you will boycott their 5G and wireless products because you do not want 4G or 5G small cells in your community.
  - G. **ATTEND** LOCAL GOVERNMENT MEETINGS AND OPPOSE 5G OR SPEAK ON SMALL CELL (4G AND 5G) WIRELESS ORDINANCE AGENDA ITEMS.
  - H. **INSIST THAT YOUR LOCAL MUNICIPALITY HAS A PROTECTIVE ORDINANCE** whether or not they are working on a new “small cell wireless” ordinance or already have one (that isn’t protective). Visit <http://www.electrosmogprevention.org/stop-5g-action-plan/stop-5g-ordinances/> for more info.
  - I. **RALLY!** PLAN, HOLD, AND ATTEND “STOP 5G” AND “BOYCOTT 5G” protest rallies, especially before and during city council meetings and related 5G events. *Check with [www.stop5gca.com](http://www.stop5gca.com) for more info on events and upcoming protests and see Toolkit below for support materials.*
  - J. **TALK TO LOCAL AND MAJOR MEDIA AND USE SOCIAL MEDIA** to spread the word.
  - K. **TAKE LEGAL ACTION** against 4G and 5G small cells in your community, based on ADA issues, safety, property devaluation, and all legal avenues available, in consultation with experienced environmental or ADA attorneys
